- 1. **Setup/Break Down**: Road will close at 8:00 a.m. All Vendors must have items in Vendor Space prior to 8:00 a.m. Booths should be set up ready to sell by 9:00 a.m. the day of the Event. Sellers are responsible for their selling spaces. *Before leaving, be sure your area is clean and trash-free.
- 2. **Staffing:** Vendor tables/booths must be manned at all times. RFYL is not responsible for merchandise or display materials.
- 3. **Vendor Responsibility:** Vendor will be fully responsible for any loss or damage to his or her property by theft, fire or casualty. RFYL & the City of Lake Stevens expressly disclaim any responsibility for same. Vendors shall be responsible for any damage which may be incurred to the facilities as a result of or in connection with its operation. Each vendor is responsible for the conduct of his employees and/or representatives, and activities must not detract from the image or welfare of the fair.
- 4. **Vendor Spaces:** Vendor spaces will be assigned. Placement, flow and competition will be taken into consideration to provide the best experience for fair attendees. If you have special space needs, please include your request with your application and we will make every effort to accommodate you. Spaces are reserved on a first-come, first-served basis.
- 5. **Direct Sales:** Only one vendor from each direct sales company will be allowed. Spaces are reserved on a first-come, first-served basis.
- 6. **Acceptance:** RFYL reserves the right to decline any application for space if it deems such action to be in the best interest of the event.
- Payment: Non-refundable* registration fee for the selected space is due with the submission of this agreement.
 *If the event is canceled by RFYL for any reason, fees will be refunded.
- 8. **Cancellation of space:** Application fees are not refundable. RFYL is not liable if weather or other conditions prevent the vendor from attending and fulfilling the contractual obligation as a vendor.
- 9. **Electricity:** Electricity will be available as a first-come, first-served basis as electricity is not available at all areas.
 - a. Outlets are NOT guaranteed.
 - b. Extension cords are not included in the fee and must be provided by the Vendor.



- 10. **Music**: Music will be provided throughout the space.
- 11. **Tables & Chairs:** Each Vendor must furnish his or her own chairs, tables, tents and/or stands.
- 12. COVID: Venders are responsible for knowledge of and compliance with all COVID-19 requirements that apply to your vendor operations at RFYL. If you are unable or unwilling to comply with any applicable requirement, you will not be allowed to vend at RFYL.
- 13. Indemnification: Vendor agrees to indemnify and hold harmless RFYL and the City of Lake Stevens from and against any loss, expense, claims, damages, causes of action, injuries, suits or damages, suits to person or property, including attorney's fees, arising out of or related to the operation of the Vendors at the Run For Your Life for Suicide Awareness Event.
